
AUDITORS REPORT

We have audited the attached Balance Sheet of Delhi High Court employees Co-operative Thrift & Credit Society Ltd. As on 31.03.2023 and the annexed Income & Expenditure account for the year ended and report that:

1. We have obtained all the information & explanations, which to the best of our knowledge and belief were necessary for the purpose of the audit.
2. In our opinion the Balance Sheet and Income & Expenditure Account referred in the report are drawn in conformity with the law.
3. In our opinion proper books of accounts have been kept by the society as required under the act and rules so far as appears from our examination of these books.
4. As per the information and explanations given to us there has been no material impropriety or irregularity in the expenditure.
5. In our opinion and to the best of our information and according to the explanation given to us and as shown by the books of the society the Balance Sheet Exhibits a true & fair view of the state of affairs of the society as on 31.03.2023.

Part-A

Audit Objections / Suggestions made in the previous audit report & compliance there of

Audit Objections /Suggestions pointed out in the previous report have been incorporated and complied and there is no compliance pending for the previous Year.

Part –B

a) The society is functioning from its registered office and members are allowed to inspect books & other documents of the society including audit report as per the provisions of rule 84(8) of the Delhi Co-operative societies rules 1973.

Comments on items of the Balance Sheet and Income & Expenditure account are as follows:-

1) Share Capital

The balance under this head as per General Ledger is Rs.3,73,62,200/-as on 31.03.2023.

2) Reserve Fund

The accumulated balance under this head was Rs. 48,76,008/- as on 31.03.2022. The amount transferred during the year is Rs.15,50,120/- and the balance becomes Rs.64,26,128/- as on 31.03.2023. The society is not investing amount of Reserve Fund in the securities as prescribed under the Byelaws, rules and act.

3) Co-Operative Education Fund

Education fund which relates to FY 2020-2021 have been paid on 04.07.2022 having receipt No.- 31380 and which relates to FY 2021-2022 have been paid on 23.08.2022 having receipt No- 31791 and the provision made for the year 2022-23 is Rs 50000/-.

4) Income & Expenditure Account

The accumulated balance under this head was Rs 1,31,62,368.67/-as on 31.03.2022. The Accumulated Income for last two years of Rs. 1,17,90,434/- has been distributed as dividend to the members. The excess of Income over Expenditure incurred during the year is Rs 62,00,478/- out of which Rs.46,00,358/- has been transferred under this head, the balance as at 31.03.2023 is Rs.59,72,292.67.

5) Compulsory Deposit (Members Deposits)

The Balance under this head is Rs. 11,10,28,169/-as per General Ledger as on 31.03.2023.

6) Loan to Members

The balance under this head is Rs 15,55,10,680/- as per the General Ledger as on 31.03.2023.



7) Investment In shares

The society has made investment in shares amounting to Rs 4800/-, no dividend has been received during the year.

8) The Society has paid accumulated balance of last two years as dividend to its members. Interest on Compulsory Deposits of Rs. 54,92,370/- has been provided in books.

) The Society has periodically reconciled its accounts with the accounts of the members. **The Society's online portal is available to all the members under their login account, online facility has increased its transparency to all the members to view the transactions made in their respective accounts.**

b) The society has raised funds so as to confirm the provision of Rules 69(1) of the Delhi Co-op Societies Rules 1973.

c) There are no outside debts other than members of the society as on 31.03.2023.

d) As per the information given to us the society grants maximum loan up to 10 times of the share capital or Rs. 300000/- whichever is less to its member including emergency loan. The society takes two sureties of the other members before granting loan to the members.

e) The management committee has implemented decisions of General Body and keeping in view the best of interest of the members of the society.

f) As per the information and explanation given to us by the management, there is no unresolved dispute of the society as on 31.03.2023.

g) As per the information and explanation given to us by the management, there is no claim against outsider parties, which are not perused properly being pending as on 31.03.2023.

h) As the society is not group housing society this clause is not applicable.

i) The society has been holding meetings of the managing committee regularly and has maintained the proceeding of the meetings in the minutes register.

j) List of the members with their ledger balance at the close of the co-operative year is being enclosed with the auditor's report. List of members enrolled and resigned/expelled during the year is also being enclosed. The Society is following the rules and the instruction for admission and expulsion of members.

k) As per the information given by the management no office bearer suffers from the disqualifications contained in sec.31 read with rule 59 & 60.

l) The expenditure incurred by the society is in the normal course of activities of the society.

m) The Society is not having any fixed assets.

n) Monthly Expenditure has been approved in the ensuing managing committee meeting.



o) The Society does not grant any loan to any outsider except its members.

p) Certificate of cash & records are enclosed.
