The Nomination forms can be obtained free of cost as per the schedule mentioned above. Nomination forms dully filled-in along with the Security Deposit of Rs.1000/- (Rupees One Thousand only) in cash to be handed over by candidate himself or by his/her Proposer or Seconder on the date and time mentioned above to the undersigned personally. A member is not eligible to contest election for two posts simultaneously. In case of member filed nomination for two posts, the member shall intimate his final choice to contest for one post on the date of withdrawal, failing which all his nomination papers shall be deemed to have been cancelled.

Further, the Candidate, Proposer & Seconder should not be a Defaulter. A member is not eligible to contest for the election if he/she has not completed minimum period of one year from the date of acquiring membership in the society to the date of filling of the nomination.

In case the candidate gets less than  $\frac{1}{6}^{\text{th}}$  of total votes polled, the security deposit shall be forfeited. The list of eligible members of the aforesaid society has been displayed at the Notice Board of office of the Society. Interested members can obtain a copy of the list of members from the society on payment of prescribed fee, as per provisions of the Delhi Co-op Rules, 2007 (As amended from time to time). The Candidates, Proposers & Seconders are requested to submit self attested copy of ID proof along with each Nomination.

## SPECIAL NOTE

The Election/Meeting shall start on 20/09/2025 (Saturday) at 10.30 A.M. At Ground Floor, A-Block, Delhi High Court, Sher Shah Road, New Delhi-110003. The quorum of the meeting will be observed upto 11.00 A.M. In case, the quorum is not completed within half hour, the meeting shall be adjourned for 15 minutes on the same day i.e. from 11.00 A.M. to 11.15 A.M. at the same place and the adjourned meeting for the election shall take place from 11.15 P.M. onwards on 20/09/2025 (Saturday). In the adjourned meeting, no quorum shall be necessary in terms of the Rules 48 (3) of DCS Rule 2007.
